

OFFICIAL SWEEPSTAKES RULES

1. **Sponsorship.** The Vegas Trip For Two or \$5,000.00 Cash Giveaway sweepstakes (the “Sweepstakes”) is sponsored by *Meyer Oil Company* with a principal place of business located at 1505 W. Main Street, Teutopolis, Illinois (the “Participating Locations”) and J&J Ventures Gaming, LLC, with a principal place of business located at 1400 Raney Street, Effingham, Illinois (together with the Participating Location, the “Sponsors”).

2. **Sweepstakes Procedure.** Participants may enter the Sweepstakes through an On-Site Entry from [December 1, 2017] to [April 15, 2018], as described below (an “Entry”). The Sweepstakes shall be open to all patrons (regardless of whether such patron has or intends to play a Video Gaming Terminal). Each person who enters the Sweepstakes via an Entry is referred to herein as a “Participant.” In connection with an Entry, a Patron may be required to provide the Participant’s: [(a) first and last name, (b) telephone number, (c) physical address and (d) e-mail address (the “Required Participant Information”). The Required Participant Information must be accurate and current as of the date of the Entry. A Participant is permitted one (1) Entry per day. All Participants must enter themselves in the Sweepstakes; a third-party (including the Sponsor’s employees) may not enter another in the Sweepstakes. In the event that a Participant fails to comply with any of the requirements contained in this Section or that are otherwise provided for herein, at the sole determination of the Sponsor, such Participant may be disqualified from the Sweepstakes. Moreover, at the sole determination of the Sponsor, all of that Participant’s Entries may be deemed null and void, not honored or acknowledged and may be grounds for forfeiture of his/her prizes.

ON-SITE ENTRY: Participants may enter the Sweepstakes via an Entry by making a request for an entry form from an employee of the Participating Location on duty at the Participating Location during normal business hours. Participant is required to fill out the entry form in its entirety and deposit it into the designated Sweepstakes drawing container.

3. **NO PURCHASE NECESSARY.** NO PURCHASE IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. FURTHER, A PURCHASE (INCLUDING, WITHOUT LIMITATION, ANY PRODUCT, GOOD OR SERVICE SOLD BY THE SPONSOR) WILL NOT IMPROVE A PARTICIPANT’S CHANCES OF WINNING WITH AN ENTRY.

4. **Drawing.** The drawing will take place at 1505 W. Main St., Teutopolis, IL (Meyer Oil Company Office) on **Friday April 20, 2018** at 11:00 AM Central Time (the “Drawing Date”). Entries will only be accepted prior to the time of the drawing. An employee of the Participating Location will conduct the drawing. The winner shall be notified via telephone within 24 hours of the Drawing Date (the “Notice”), and shall have seven days from the date and time of the Notice to claim his or her Prize (the “Claim Period”). If the winner does not claim the Prize within the Claim Period, the Prize shall be forfeited and a secondary drawing shall occur at a date and time decided upon by the Sponsors (the “Secondary Drawing”). No additional Entries shall be accepted between the expiration of the Claim Period and the Secondary Drawing.

5. **Prizes, Prize Values, Odds of Winning and Collecting Prizes.**

- (a) By entering the Sweepstakes, Participants are eligible to win either a trip for 2 to Vegas in the form of a \$5,000.00 travel voucher to Effingham Travel Agency or \$5,000.00 cash. If the participant does not choose the trip, they can claim the \$5,000.00 cash prize.
- (b) The odds of winning depend entirely on the number of Entries made prior to the Drawing Date.
- (c) Because the Prize must be collected in person, there are no shipping or handling fees or charges associated with collecting the Prize.

6. **Eligibility.** The Sweepstakes is open to all legal residents of the United States of America who are twenty-one (21) years or older at the time of entry. The Sweepstakes shall be open to all patrons who meet these criteria, regardless of whether such patron has or intends to play a Video Gaming Terminal. As applicable, employees of either Sponsor, its affiliates, licensees, franchisees, advertising and promotional agencies and the immediate family members of each are not eligible. An “immediate family member” is defined to mean spouse, parent, grandparent, child or sibling. In-laws are not considered to be immediate family members.

7. **Use of Disclosed Information.** Information transmitted to the Sponsors will generally be treated as non-confidential and non-proprietary. Except where prohibited by law, entry constitutes permission to use each winner's name, biographical information and/or likeness for online posting and/or any other written or photographic advertising and publicity without additional compensation. Further, by entering the Sweepstakes, the Participant is granting Sponsor permission to use his/her contact information to provide him/her with marketing or other informational materials related to Sponsor.

8. **Facebook Disclosure.** Although this Sweepstakes may be advertised on the Facebook pages of the Sponsors or another, this Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook. Participants are providing their information to Sponsors and not to Facebook. The information a Participant provides will only be used by the Sponsors. By entering, Participants provide a complete release of Facebook from any and all responsibilities implied or provided by Sponsors and that this Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook.

9. **Miscellaneous.**

- (a) By entering, Participants unconditionally agree to be bound by these rules and the decisions of the Sponsor, which shall be final. Sponsor reserves the right to disqualify any Participant or winner who, in its sole suspicion, tampers with the entry process, violates these rules, or acts in an unsportsmanlike or disruptive manner.
- (b) All federal, state, and local laws apply.
- (c) Sponsors and, as applicable, the employees, officers, directors, shareholders, agents, and representatives of the Sponsors, their affiliates, subsidiaries, and advertising, promotion and legal advisors are not responsible for and shall not be liable for: (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible Entries; (ii) any condition caused by events beyond the control of either Sponsor that may cause the sweepstakes to be disrupted or discontinued; (iii) any injuries, losses, or damages of any kind caused by a prize or resulting from acceptance, possession, or use of the Prize, or from participation in the Sweepstakes; or (iv) any printing or typographical errors in any materials associated with the sweepstakes.
- (d) Participants agree that any dispute arising out of this Sweepstakes shall be resolved individually without class action and exclusively by the state and federal courts in Cook County, Illinois under the laws of Illinois, without regard to that state's conflict of laws principles.
- (e) For the name of the winner or an additional copy of the Official Rules, send a self-addressed stamped envelope request to the principal place of business of the Participating Location identified in Section 1 above. The name of the winner will be available on or after three (3:00pm) the day after the Drawing Date.
